Work must conform to the following:

1. Please call Code Enforcement Department at 215-361-8333 to schedule all inspections at least 24 hours prior to start of any work.
2. All curbs to be formed using steel forms as per PennDOT publication 408, latest edition.
3. **No concrete is to be poured without the Borough inspector's approval.**
4. Work begun before obtaining permit is subject to a penalty fee of 2x permit cost.
5. Sub base must be inspected prior to installation of stone. Forms must be inspected prior to pouring. When work is complete a final inspection will be performed.

The following are violations which will result in fines being issued:

1. Proper Safety Controls must be provided where required. § 329-12
2. Trash, Debris and clean up requirements. § 329-13
3. Road Closing Procedures, Requirements and Restrictions. § 329-16
4. Provide Certificate of Insurance for Contractor (can be faxed to 215-361-8393).
